
# VTCT Level 2 NVQ Diploma in Beauty Therapy

## VTCT Level 2 NVQ Diploma in Beauty Therapy

This qualification has been specifically designed for the 16-18 age group and will develop the knowledge and skills to prepare learners for employment as a beauty therapist. Learners will have their beauty therapy skills assessed in a real working environment.

**This qualification includes all the required elements to work effectively as a beauty therapist including:**

- Provide Facial skincare treatment
- Enhance the appearance of eyebrows and eyelashes
- Carry out Waxing services
- Provide Manicure services
- Provide Pedicure services
- Develop and maintain effectiveness at work
- Ensure responsibility for actions to reduce risks to health and safety
- Promoting additional services or products to customers

### Start Dates

Intake every September.

### Course Expectations and Breakdown:


The course is 3 days per week, during term time, for 1 year.

### Who is this qualification for?

The VTCT Level 2 NVQ Diploma in Beauty Therapy General is a substantial vocational qualification for learners seeking a career as a beauty therapist.

### Entry

As a government requirement, and an essential aspect of the Beauty Therapy course, you will be required at the time of enrolment, to sit an initial assessment and diagnostic tests. This allows Reynolds to gauge your level, acknowledge prior achievement and qualification(s) and identify any support that you may need.

## VTCT Level 3 NVQ Diploma Beauty Therapy Massage



The primary outcome of the VTCT Level 3 NVQ Diploma in Beauty Therapy Massage is to confirm your competence in the job role of beauty massage therapist. All the units in this qualification relate directly to the specific job role of a beauty massage therapist.

**This is a vocational qualification and includes all the required elements to work effectively as a beauty massage therapist including:**



- Provide body massage treatments
- Provide Indian head massage
- Carry out massage using pre-blended aromatherapy oils
- Provide stone therapy treatments
- Monitor procedures to safely control work operations Contribute to the planning and implementation of promotional activities.
- Contribute to the planning and implementation of promotional activities.

## VTCT Level 3 NVQ Diploma Beauty Therapy Massage

### Start Dates

Intake every September.

### Course Expectations and Breakdown:


The course is 3 days per week, during term time.

### What does this qualification cover?

VTCT Level 3 NVQ Diploma in Beauty Therapy Massage allows you the opportunity to learn beauty massage skills, whilst working on real clients. It is important for you to have the opportunity to learn in a real working environment, particularly because this qualification leads to employment in such a client-centred and service orientated sector.

### Entry

Learners will need to have already attained a Level 2 qualification in beauty therapy and have a successful skills test and interview to be accepted onto the course.

- Learners can also complete an optional 1-day Professional Beauty Guild Accredited Spray tan course at an additional fee of £100.




## Career Opportunities


### What could this lead to?

This qualification will prepare you for employment as a beauty massage therapist. You will also be eligible to join a professional association and gain insurance as a beauty massage therapist.

Career opportunities as a beauty massage therapist exist in a variety of contexts, including:

- Working in commercial beauty salons
- Working in destination and day spas
- Working independently/self-employed/mobile/home-based settings
- Working in retreat settings





## Who Supports this Qualification?

This qualification is based on the beauty therapy National Occupational Standards (NOS) and is recognised by the UK's leading professional associations; the British Association of Beauty Therapy and Cosmetology (BABTAC) and the Federation of Holistic Therapists (FHT) as being fit for purpose to confirm your competence as a beauty massage therapist.

Holders of this qualification are eligible to become a professional member of BABTAC. Further information on BABTAC membership can be found on their website.



# VTCT Level 4 Diploma in Advanced Beauty Therapy



## VTCT Level 4 Diploma in Advanced Beauty Therapy

The primary outcome of the VTCT Level 4 Diploma in Advanced Beauty Therapy is to prepare you to enter the beauty therapy sector as an **advanced senior beauty therapist.**

### Start Dates

Intake every September.

### Course Expectations and Breakdown:

The level 4 course is 2 days per week, during term time.

### What does this qualification cover?

The VTCT Level 4 Diploma units contained in this qualification cover all the skills and knowledge required for the role of advanced senior beauty therapist.

### Entry requirements

Entry on to this qualification is via previous attainment of a beauty therapy qualification at level 3.



## Level 4 Diploma in Advanced Beauty Therapy

**The advanced techniques covered in the mandatory section of this qualification include:**

- Laser and light treatments for hair removal
- Laser and light treatments for skin rejuvenation
- Apply Microdermabrasion
- Chemistry of hair and beauty products
- Dermatology and microbiology
- Physiology of ageing
- Management of health safety and security in the salon
- Quality management of client care in the hair and beauty sector
- Salon management

**Additional content on the level 4 Advanced Beauty Therapy course includes:**

- Public relations (PR) in the hair and beauty sector.
- Industry week.
- One day visit to professional beauty show.



## VTCT Level 4 Diploma in Advanced Beauty Therapy

### What could this qualification lead to?

This qualification will qualify you to gain employment as an advanced senior beauty therapist. This is the only VTCT qualification in advanced beauty therapy. Once you have completed your Level 4 qualification you will be able to continue to study onto Level 5 and Level 7 **Aesthetic** Qualifications.

### Who supports this qualification?

This qualification is based on the Habia National Occupational Standards (NOS) and is recognised by the leading professional association representing owners of hair and beauty salons, the Federation of Holistic Therapists (FHT), as being fit for purpose to prepare you for employment as an advanced senior beauty therapist. Holders of this qualification are eligible to become members of FHT. Further information on FHT membership can be found on their website.

### To be eligible to join:

- You must not actively be enrolled in, or attending, another government funded course.
- You must have been living in the UK or EU for 3 years+
